**SUBJECT: Transition to New Substance Use Disorder Prevention and Mental Health Promotion Online Reporting System (Minerva 2.0)**

As previously shared with tribes in different forums, Health Care Authority's (HCAs), Division of Behavioral Health and Recovery has purchased a new Substance Use Disorder (SUD) prevention services online reporting system to replace the current SUD prevention and MH promotion online reporting system known as Minerva 1.0 with Minerva 2.0. HCA is now in the process of transitioning to Minerva 2.0. Please see the enclosed transition timeframe for details.

All tribes and urban Indian organizations (UIOs) with an agreement or contract with HCA to provide SUD prevention and MH promotion services will have to transition to Minerva 2.0. The data that is being collected remains the same. HCA is committed to minimizing the impact of this change on our tribal and UIOs by:

- Migrating previously entered data to Minerva 2.0.
- Providing tribal/UIO specific training on the dates and time below.
  - We ask that all individuals who will be needing a Minerva 2.0 account to register for at least one of the trainings, no later than March 14, 2022.
