About Our Community

The **city of Longview** is located on the Columbia River and the I-5 corridor in Southwest Washington, 45 miles north of Vancouver, WA. At approximately a 46,000 population, Longview is the largest urban area in Cowlitz County. The Longview economy has been somewhat restored since the 2008 recession, but it continues to be a natural resources economy that is continually impacted by environmental laws and lobbies.

Longview School District covers all of Longview plus a portion of Cowlitz County to the west.
