Our highest priority is to reduce underage drinking among 8th and 10th grade students. By providing evidence-based practices and promoting the positive changes we can build healthier communities.

About the Coalition: Communities and Schools Working Together

The Bremerton Substance Abuse Prevention Coalition is a grassroots volunteer organization formed in May of 2012 for the purpose of mobilizing the Bremerton community to prevent and reduce youth substance abuse. We work in partnership with representation from all parts of the community: youth, education, law enforcement, local government, healthcare, treatment, faith-based organizations, volunteer groups, youth organizations, parents, business, and the media to effectively support our children & youth to live substance free. Leading by example, Mayor Lent is a founding member of the Coalition. The City took its commitment one step further and in 2013-2014 dedicated funds to support a new School Resource Officer position and an alcohol and tobacco retailer compliance check. The Police Department, the coalition and local youth partnered to conduct an Alcohol and Tobacco Retailer Compliance Check on 18 Bremerton businesses.

Our youth prevention club at Bremerton High School assisted by the CPWI funded Prevention Interventionist, conducted a successful student social norms prevention campaign with multiple events and messaging.





About Our Community

- The City of Bremerton, incorporated in 1891, is located in central Kitsap County and lies east of the Olympic Mountains directly across Puget Sound from Seattle. Bremerton was founded because of its proximity to the recently established Naval Base. Bremerton is the county's largest city with a population of 39,572 the largest employer is the Federal defense agency which includes Naval Base Kitsap. It is the largest active shipyard in the nation and employs over 16,000 civilians and active duty military. The population of Bremerton is 99% urban with a median household income of \$40,644 and 21.1% live below the poverty level. Its population is 72.7% White, 9.9% Hispanic or Latino, 6.7% African American, 7.4% Asian, 2% American Indian and 1.3% other.

Like many mid-size cities, Bremerton is challenged with a higher rate of youth substance abuse, delinquency, and poverty than the rest of the county and the state. This is characterized by lower school performance, increased use of tobacco products, alcohol, and other substances, and students struggling with depression, mental health issues and suicidal thoughts. Our coalition is concentrating efforts to provide a web of support to Bremerton's children, youth, parents, and the community as a whole. Our greatest challenges are the use of legal marijuana & the increase in opiate use. Our greatest strength is our ability to work together effectively to solve community problems and fill gaps in services.

About Prevention Programs in our Community

Our main goal is to decrease youth substance use.

We will accomplish this through community-wide collaboration; education regarding the effects of drugs and alcohol; and strategies to prevent and reduce youth substance use; decreasing youth access to alcohol and other drugs; school-based intervention and prevention services; youth and parent social norming; and through activities, events, policies and programs that support a substance-free lifestyle.

We will offer and evaluate the effectiveness of topic specific prevention education including strategies to recognize and prevent youth substance use, Youth Mental Health First Aid, Retailer Education, resiliency building strategies, Strengthening Families Program and the Curriculum-Based Support Group Program.
