2016 Legislative Session –Marijuana Bills

Bill/Companion Bill	Title/Description
HB 1438	Permitting cities, towns, and counties to prohibit the production, processing, and sale of marijuana under Initiative Measure No. 502 only by public vote— Feb 12 Placed on second reading by Rules Committee.
HB 2347	Reducing the tax on useable marijuana, marijuana concentrates, and marijuana-infused products— Mostly Dead
HB 2365	Allowing marijuana retailers to sell marijuana merchandise (wearable apparel)-- Feb 5 Referred to Rules 2 Review
HB 2368	Creating a two-year pilot program authorizing qualified licensed marijuana retailers to deliver marijuana to Washington residents in a city with a population of over six hundred fifty thousand. Feb 12 Placed on second reading by Rules Committee.
HB 2693—MJ Lounges SB6375— MJ Clubs	Dead
HB 2522/SB6302	Establishing crimes related to minors entering, remaining in, or being served by a marijuana retail outlet. IN THE SENATE: Feb 19 First reading, referred to Law & Justice.
HB 2494/SB6486	Concerning penalties for marijuana offenses. Establishes penalties for possession by persons under 21. Establishes clarification for allowable amounts in WA and penalties related to violating possession of amounts in excess of allowable amounts. IN THE SENATE: Feb 17 First reading, referred to Law & Justice.
SB6236	Authorizing the growing of industrial hemp--for research purposes only until August 2017. Feb 25 Scheduled for executive session in the House Committee on Commerce & Gaming at 8:00 AM.

HB 2313/SB6157	Concerning the age of individuals at which sale or distribution of tobacco and vapor products may be made. DEAD
E2SHB1645	Concerning youth substance use prevention associated with tobacco and drug delivery e-cigarettes and vapor products-- IN THE SENATE: Feb 16 First reading, referred to Health Care.
SB 6236	Concerning the 24/7 sobriety program. Feb 15 Placed on second reading by Rules Committee.
HB2342	Concerning performance of personal services by members of the liquor industry to retailers. IN THE SENATE: Feb 19 First reading, referred to Commerce & Labor.
ESHB 1448/SB5781	Providing procedures for responding to reports of threatened or attempted suicide. Feb 23 Scheduled for public hearing in the Senate Committee on Human Services and Mental Health & Housing at 10:00 AM.
HB 2793	Providing for suicide awareness and prevention education for safer homes. Feb 25 Scheduled for public hearing in the Senate Committee on Human Services and Mental Health & Housing at 10:00 AM. Scheduled for public hearing in the Senate Committee on Human Services and Mental Health & Housing at 12:00 PM.
SB 6243	Concerning a training program for educators and parents to develop students' social and emotional skills to help prevent youth suicide. Feb 22 Scheduled for public hearing in the House Committee on Education at 1:30 PM.
HB2730	Concerning the prescription drug monitoring program. Revised for 1st Substitute: Concerning the prescription monitoring program-- Feb 22 Scheduled for public hearing in the Senate Committee on Health Care at 10:00 AM.
